Vide reference 2nd cited, an amount of Rs. 73.33 Crores sanctioned to the SERP towards payment of relief amount to the Accidental death claims under State Accident Scheme i.e component of PMJJBY-Chandranna Bima Scheme.

Vide reference 3rd cited the Commissioner of Labour, Government of Andhra Pradesh has requested the Secretary & CEO of APBOCWW Board for sanction of Rs. 62.75 crores amount to the CEO, SERP under State Scheme Component of PMJJBY – Chandranna Bima for transfer of balance claim amount to nominees under State Scheme Component. An amount of Rs. 62,75,00,000/- (Rupees sixty two crore seventy five lakh only) was credited in to the CEO, SERP, AABY SB A/c on 20/11/2018 from APBOCWW.

It is proposed to sanction balance relief amount @ Rs. 1 lakh for the age group of 18-50 years, Rs. 2.25 lakh for the age group of 51-60 years and @ Rs. 3 lakhs for the 61-70 years age group members claims under State Scheme component of PMJJBY-Chandranna Bima Scheme for the claims already verified and sanctioned by New India Assurance Company under PMSSBY Scheme to ensure transfer of full claim amount of Rs. 5 lakh under PMJJBY-Chandranna Bima scheme as per the scheme guidelines from the funds sanctioned vide reference 3rd cited.
